- In good standing in the community and at school (i.e. not on disciplinary or academic probation)
- Proficient in Microsoft Applications (Word, Excel, Power Point, Outlook)
- Self-motivated and a disciplined work ethic
- Effective verbal and written communication skills

ASSIGNMENTS MAY INCLUDE:

- Interacting with key business leaders and mentors
- Assisting with researching department and business issues, synthesizing data, and creating reports
- Preparing presentations, training materials, and other communication memos
- Participating in special projects such as process improvement through the Kaizen process
- Completing assigned enrichment/learning tasks that will be provided by the intern sponsor
